RESOLUTION NO. 11

k. B.Com.(A & F), B.Com.(B & I), B.Com.(FM)

Board of Studies was held on 8th December, 2018. Internal evaluation component was modified and an average of 20 marks to 10 marks was adopted. Semester end examination was decided to be as per provided in syllabus.

I. Mass Media

Board of Studies was held on 15th December, 2018

 The Internal test format which is out of 20 marks and of 30 minutes duration to be followed from the current semester. The 'Fill in the Blanks' component to be replaced with "True or False with reasons "in order to avoid rote learning and encourage questions of Higher Order Thinking.

- The Board strongly recommended that to take advantage of autonomy and revert to the 60/40 External/Internal marks bifurcation in the next academic year. This would enhance the scope of the application and truly equip the students for the industry.
- 2) To initiate measures for improving the quality of teaching, frame rules for

conduct of examinations, rules of students' evaluation and develop student advisory programmes.

It was informed by the Controller of Examinations that OSM (On Screen Marking) has been introduced at college level from this academic year. Result declaration has been done on time.

It was suggested by the expert nominated by Governing body Prin. K. Venkatramani to upload the synoptic answers on website and also if possible send it to the students e-mail.

3) <u>To make rules for sports, extra-curricular activities, for proper maintenance</u> and functioning of the building, libraries, laboratories, etc.

Committee has been formed for this purpose and was placed before the Principal for ratification and placing before Governing Council / Board of Management.

 To recommend to the Board of Management, the proposal to institute new programmes of studies.

RESOLUTION NO. 12

Resolved that the following courses be and are hereby approved to start from the academic year 2019-20. All the new programmes are based on Choice Based Credit System (CBCS). It was noted that the new Programmes are catering to employability, entrepreneurship and skill development.

- B.Com. (Honours) in Actuarial Science.
 - It was suggested to keep the nomenclature as B.Com. (Honours) in Actuarial Studies.
 - B.Com. (Honours) in International Accounting
 - B.A. (Honours) in Apparel Design & Construction
 - M.A. (Psychology)

The same would be send to the Governing Council / Board of Management for final approval.

5) <u>To recommend to the Board of Management, institution of scholarships,</u> <u>studentships, fellowships, prizes and medals, and frame rules for the award</u> <u>of the same.</u>

College should take initiative to mobilise funds for the scholarship for institution of awards and Principal be authorized for the same.

6) To advise the Board of Management on matters pertaining to the academic affairs.

This point has been covered in Item No.4 above and the Academic Board has decided to drop this item and merge it with Item 4.

7) <u>To perform such other functions and such other duties as may be necessary</u> and as may be assigned by the Board of Management, pertaining to the academic programmes and development.

It was decided to conduct Academic Audit in the month of April, 2019.

8) <u>To approve the minutes of this meeting and send the recommendations to the</u> Board of Management.

The minutes of this meeting was read and the recommendations has been forwarded to the Governing Council / Board of Management for approval.

9) Any other business with the permission of the chair.

The Expert nominated by Governing body Prin. K. Venkatramani suggested following:

- a) Journal at the college level
- b) To start with any such programme which would fill in the gap between education and employability.
