- It was decided that from 2019- 2020 onwards the nomenclature of the Department would be BA Multi Media & Mass Communication. This would be of immediate effect applicable from the current batch of First Year Students.
- The Board overwhelmingly welcomed the 60/40 Marks distribution. The members approved the paper pattern of the External Examination and the decision to do away with the test component in the CIE .Instead focus would be on testing the application quotient of the learner. This will be applicable from 2020 onwards with the first-year batch onwards.
- However, The Board expressed its opinion strongly that this pattern should be implemented concurrently with the second and third years from academic year 2020 onwards.

2) To recommend to the Governing Body, the proposals for institution of new programmes of study.

Principal informed the members that the following new courses will be starting from academic year 2020-2021 under Autonomy.

1. Bachelor of Interior Designing (BID)
2. B.Com. (Honours) in Professional Accountancy & Financial Management

4. B.Sc.(Hons.) - Nutrition and Dietetics
5. **B.A. B.Ed. Integrated**
